- **\*\* IMPORTANT:** "Day of Match" entries will close **15 minutes prior** to the **scheduled published** start time for each group listed to the left. **No exceptions!**
- Group judging will occur after completion of the breed judging for that group: best puppy then best adult.
- Wins at this match carry no championship points. Major pointed dogs may compete. No dogs may be shown with taped ears. Poodles must be in show clip.
- Conformation champions may **not** compete.
- Professional handlers may show their own dogs or dogs owned by members of their immediate family.
- Jr Show Classes: 6-8yrs, 9-11yrs, 12-14yrs, 15-18yrs

**\*NOTE:** Actual start times may be later (not earlier) and will depend on entry for the previous group(s)

- Breed Classes: Puppy – 3-6 mo, 6-9 mo, 9-12 mo

## DIRECTIONS

---

**FROM US 422: Take Route 202 South approximately 10 miles.** Take the US-30-Business Route/US-30 East exit toward EXTON/FRAZER. At the bottom of the exit ramp, turn RIGHT onto LINCOLN HWY/US-30 BUSINESS West. Go approximately 1 mile on East LINCOLN HWY/US 30 BUSINESS WEST.

Turn LEFT onto SPRINGDALE DRIVE. The East Lincoln Highway entrance to Springdale Drive is posted "Whiteland Business Park." Dog Training Club of Chester County (DTCCC) is the first building on the left. The entrance faces Springdale Drive. Look for the black awning above the door. Parking is available around the building and in the lot across from the front entrance. Unloading at the building is permitted.

**FROM PA Turnpike from the East:** Exit PA Turnpike at the Valley Forge Exit. Follow signs for 202 South. Follow as above.

**FROM PA Turnpike from the West:** Exit PA Turnpike at the Downingtown Exit (#312). Take Route 100 South for 4.5 miles. Turn Left onto Route 30 BUSINESS. Go 1.5 miles and turn right on Springdale Drive. Follow as above.
