- Breeds are judged alphabetically in each group. The breed order and number of dogs in each breed within the group will be posted ringside 5 minutes before the start of the judging for that group.
- Group judging (puppy then adult) will occur after completion of the breed judging for that group.
- Best Puppy in Match & then Best Adult in Match will be judged after completion of all group judging for each match.

- PRE-ENTRIES CLOSE JUNE 2 at NOON

DAY-OF-MATCH ENTRY for each match

- Each regular entry \$15
 Jr Showmanship \$8 or FREE as 2nd entry
- **ENTRIES CLOSE 15 MINUTES PRIOR TO SCHEDULED START TIME FOR EACH GROUP**

Various Pesky Details

- Wins at these matches carry no championship points.
- No dogs may be shown with taped ears. Poodles must be in show clip.
- Professional handlers may show their own dogs and/or dogs owned by members of their immediate family ONLY.
- Major-pointed dogs may compete in the Open class.
- Miscellaneous class breeds will show in their assigned future group.
- Valley Forge Kennel Club and Delaware Valley Hound Association reserve the right to make changes in the judging panel if necessary. The ring order will not change.
- All AKC rules and regulations concerning training and correction will be observed.

General Information

- **PRE-ENTRIES VIA www.ValleyForgeKC.org/match OPEN AT 9:00AM MAY 21.**
- The park has many shady areas to set up crates and chairs.
- Conformation rings will be in the shade.
- Majority of vehicle parking will be on a grass soccer field in full sun.
- Please bring your own chairs.
- No food or beverages will be sold on site. Various options are nearby where food and beverages are sold.
- Portable toilet available on site.
- No electricity available. No generators are permitted per park rules.
- Be courteous to those near your set-up. Clean up after yourself and your dog(s).

Driving Directions

- **From I-276W or I-76E (PA Turnpike):** Take exit 326 (Valley Forge) to I-76E and continue per next.
- **From I-76 (Schuylkill Expressway):** Exit at US-422W and continue per next.
- **From US-422W:** Exit at Collegeville (PA-29). Turn right at light and continue per below.
- **From US-422E:** Exit at Collegeville Rd (PA-29). Turn left at light and continue per next.
- **From PA-29 at US-422:** Proceed 2.4 miles and turn left on Main Street (McDonald's on left). Proceed 1.1 miles through Ursinus College and turn left on W 1st Ave. Go 0.2 miles to entrance of park.
